Canadian Model Update

Stakeholder meetings have been underway since Fall 2017 to update certain clauses of the current Canadian Model Version 5.0, and to align the model so it can be used by members of COAA (heavy industrial construction sector) and by members of Energy Safety Canada (upstream oil and gas sector). The goal is to reach consensus on Version 6.0 and have approval by the COAA Board and the Board of Energy Safety Canada in mid 2018.

Anticipated synergies of a common Canadian Model include:

- Acceptance of the same model by two sectors adds to credibility as an “industry standard”
- Congruent policies in upstream and oil sands departments of owner companies
- Common training resources

CHANGES TO ALBERTA HEAVY HAUL STANDARDS

A recent change has been made to the standards for hauling heavy loads on Alberta's designated highways. The maximum allowable load may be increased from 375,000 lbs to 500,000 lbs by the use of a three-file trailer system. This change comes after considerable effort on behalf of the Construction Owners Association of Alberta in conjunction with the Alberta Chamber of Resources and the Consulting Engineers of Alberta. This change will allow for denser and more complete modules to be shipped from major manufacturing centers to the field. Allowing more modularized construction will reduce the capital costs of new projects, increase safety for workers and reduce transportation emissions.
